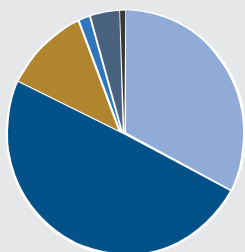

CREDIT QUALITY DISTRIBUTION²

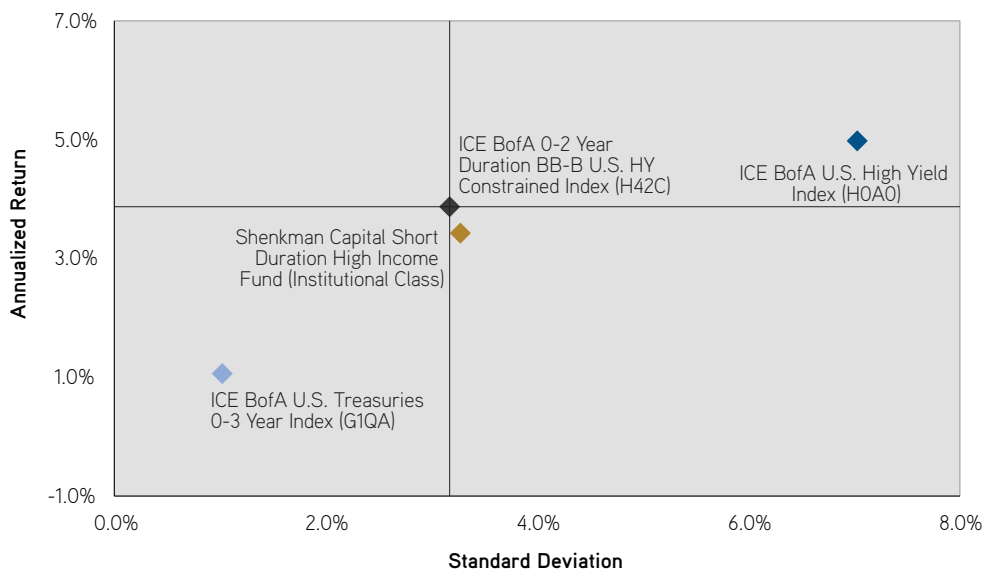

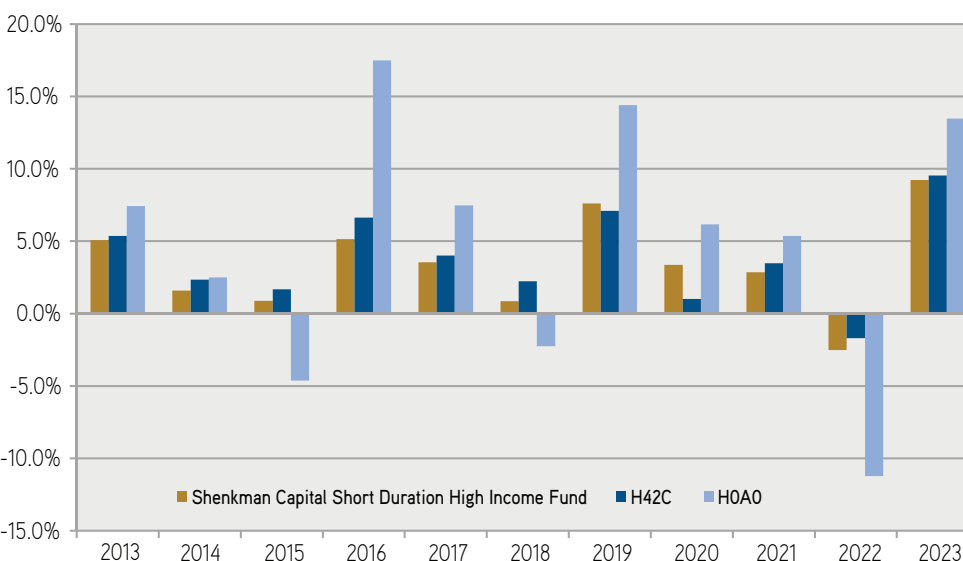

HIGH YIELD MARKET COMMENTARY

In the past month, U.S. Treasury rates decreased as the 2-year yield decreased by -28 basis points (bps) and the 10-year yield decreased by 12 bps. During September, the high yield bond market, as measured by the ICE BofA U.S. High Yield Index (H0A0), returned 163 bps. The month culminated with a yield-to-worst of 6.98%, decreasing 36 bps since August and 71 bps from the start of the year. The H0A0's spread-to-worst came in at 330 bps, down 16 bps since August and 33 bps from the start of the year. The average dollar price ended at 96.72, increasing 1.25 for the month and 3.86 for the year. The higher-quality short duration segment of the high yield market, as measured by the ICE BofA 0-2 Year Duration BB-B U.S. HY Constrained Index (H42C), also posted a relatively strong return for the month, albeit constrained by its stronger credit quality. The H42C returned 0.62%, while shorter-dated U.S. Treasuries, as measured by the ICE BofA 0-3 Year U.S. Treasury Index (G1QA), delivered a monthly return of 0.72%, driven by the drop in front end yields.

By rating, CCCs outperformed with a return of 5.21%, BBs underperformed with a return of 1.10%, and Bs had a return of 1.19%. By sector, Cable & Satellite outperformed at 6.53%, while Oil & Gas underperformed at -0.35%. By duration, the 6-8 year option-adjusted-duration (OAD) bin outperformed at 2.09%, compared to the 8-10 year OAD bin, which underperformed at 1.00%.

The high yield bond default rate declined to 0.94% as of September month-end, and the leveraged credit default rate, which includes bonds and loans, ended the month at 1.11%. The upgrade-to-downgrade ratio for U.S. high yield came in at 1.9:1 for the month. New issuance increased to \$36.6 billion over the month, doubling the issuance in August. The market also saw approximately \$3.7 billion of "Rising Stars" and \$2.6 billion of "Falling Angels" over the month.

FUND COMMENTARY

The Shenkman Short Duration High Income Fund (the "Fund") (SCFIX) posted a return of 0.69% for the period, trailing the broader high yield market, as measured by the H0A0, and slightly behind shorter-dated U.S. Treasuries. Fund performance by credit rating largely echoed the broader high yield market's pattern, with CCC-rated credits posting the strongest returns while BB-rated and B-rated credits posted more modest returns. On a sector basis, all sectors posted positive returns with Leisure, Gaming, Travel and Healthcare posting the strongest contributions to absolute returns while Consumer Staples Discretionary and Midstream posted the smallest contributions. The Fund's duration-to-worst remained unchanged to 1.4 years while the Fund's average bond price edged higher to \$100.7. The Fund's average final maturity was little changed at 2.5 years, while primary issuance and refinancing activity surged from a seasonally slow August. As a result, corporate action activity in the Fund also accelerated from August. During the month, 7 bonds were called or tendered, representing \$52.8 million in proceeds (approximately 2.9% of the Fund's average market value) which were redeployed in other short duration opportunities at what we believed were relatively attractive levels given the continued discount price environment. The Fund continues to seek compelling risk-adjusted return opportunities and strong credit selection as it remains mindful of liquidity risks.

The market appears to be seeing a rate path that could be positive for credit and the economy. Access to capital is also helping create a relatively low credit risk environment and year-to-date there has been compression in yields between sectors like CCCs and the rest of the market. This spread between the ICE BofA CCC & Lower US High Yield Index (H0A3) and the ICE BofA BB-B US High Yield Index (H0A4) is at the tightest it has been all year at 550 bps, but these relationships can change rapidly. While the refinancing cycle will likely continue to push off debt maturities, we do believe increased M&A activity and the possibility of some Fallen Angels could reshape the leveraged debt markets over the next year and change the risk profile of the market and perhaps dispersion of yields and performance. We continue to believe the higher-quality short duration segment of the high yield market remains well positioned as a lower volatility solution with the ability to capture attractive risk-adjusted returns in the current environment.

Coupon is the periodic interest payment made to the bondholders during the life of the bond. Prepayment risk refers to payments made in excess of scheduled mortgage principal repayments.

Coupon rate is the nominal yield paid by a fixed-income security. It is the annual coupon payments paid by the issuer relative to the bond's face or par value.

Duration is a measure of the sensitivity of the price of a fixed-income investment to a change in interest rates; it is expressed as a number of years.

Duration-to-worst is the duration of a bond computed using either the final maturity date, or a call date within the bond's call schedule, whichever would result in the lowest yield to the investor.

Effective duration is a duration calculation for bonds with embedded options. Effective duration takes into account that expected cash flows will fluctuate as interest rates change.

The European Central Bank (ECB) is the central bank responsible for monetary policy of the European Union (EU) member countries that have adopted the euro currency.

A fallen angel is a bond that was once rated as investment grade but has fallen to junk-bond status because of the issuing company's poor credit quality. A rising star is a bond that is rated as a junk bond but could become investment grade because of improvements in the issuing company's credit quality.

Mergers and acquisitions (M&A) is a general term that refers to the consolidation of companies or assets through various types of financial transactions. M&A can include a number of different transactions, such as mergers, acquisitions, consolidations, tender offers, purchase of assets and management acquisitions.

Option Adjusted Duration (OAD) is a measure that helps approximate the degree of price sensitivity of a bond to changes in interest rates adjusted for the option to call or put.

Option Adjusted Spread (OAS) is the measurement of the spread of a fixed-income security rate and the risk-free rate of return, which is adjusted to take into account an embedded option.

Par - The term at par means at face value. A bond, preferred stock, or other debt instruments may trade at par, below par, or above par.

Tenor refers to the length of time remaining before a financial contract expires.

S&P ratings represent Standard & Poor's opinion on the general creditworthiness of a debtor, or the creditworthiness of a debtor with respect to a particular debt security or other financial obligation. Ratings are used to evaluate the likelihood a debt will be repaid and range from AAA (excellent capacity to meet financial obligations) to D (in default). Spread is the percentage point difference between yields of various classes of bonds compared to treasury bonds.

Spread-to-worst (STW) measures the dispersion of returns between the best and worst performing security in a given market, usually bond markets, or between returns from different markets.

Yield-to-Maturity is the rate of return anticipated on a bond if it is held until the maturity date.

Yield-to-Worst is the lowest possible yield from owning a bond considering all potential call dates prior to maturity.
