

MONTHLY COMMENTARY

February proved turbulent as markets digested escalating Middle East tensions that pushed oil prices higher, renewed tariff uncertainty following the Supreme Court's ruling on presidential emergency powers, and mounting concerns over AI-driven economic disruption across key sectors. Persistent inflation continues to complicate the Federal Reserve's policy calculus, keeping rate cuts on hold despite softening growth indicators. Equity markets sold off on mounting anxiety, while safe-haven assets, namely Treasuries and investment-grade bonds, posted strong gains as many investors rotated toward quality. The month underscored a critical inflection point as U.S. economic resiliency now faces its first meaningful test amid conflicting macro signals and a new war in the Middle East.

The leveraged loan market, as measured by the Morningstar LSTA US Leveraged Loan Index, returned -0.78% in February amid shifting risk sentiment and continued Tech sector selling pressure. Returns by rating exhibited clear risk aversion as BB and B rated loans returned 0.17% and -1.11%, respectively, while CCC & below rated loans declined by -3.06%. Liquid loans, as measured by the Morningstar LSTA US Leveraged Loan 100 Index, returned -1.39%. The top performing industries included Chemicals and Personal Care Products, while the performance laggards included Software and Building Products.

Primary leveraged loan market activity subsided in February with \$314 billion coming to market. From a demand standpoint, collateralized loan obligation (CLO) issuance remained robust as \$40.1 billion (gross) priced in February, while net volume of \$19.5 billion (excluding refinancings and resets) was the second highest in seven months. One loan issuer defaulted in February totaling \$0.7 billion following an upwardly revised three issuer defaults in the prior month affecting \$3.4 billion in par value. The J.P. Morgan 12-month par-weighted leveraged loan default rate increased 3bps to 1.55%, remaining well below the historical average default rate of approximately 3% and with activity remaining largely idiosyncratic rather than systemic.

Leveraged loans continue to benefit from elevated coupons and robust CLO demand, while their floating-rate structure offers inherent protection against lingering Fed policy uncertainty and potential rate volatility. We expect carry to remain the dominant return driver through 2026, though issuer selection, capital structure positioning, and sector-level dispersion could increasingly dictate relative performance. We anticipate AI adoption and potential disintermediation, whether valid or not, will widen performance dispersion across sectors and within capital structures, reinforcing the need for disciplined underwriting and granular, issuer-specific credit analysis. Recent market turbulence underscores this dynamic, as fundamental quality and strategic positioning matter more in an environment where macro tailwinds can shift rapidly.
