The Shenkman Capital Floating Rate High Income Fund employs a conservative approach which focuses on principal preservation. Portfolios are well diversified across issue, issuer, and industry.



MONTHLY COMMENTARY

The leveraged loan market, as measured by the Morningstar LSTA US Leveraged Loan Index, returned 0.36% in November as elevated coupons and robust collateralized loan obligation (CLO) formations continued to provide potential opportunities for the asset class. Returns by rating reflected a quality bias in favor of higher-rated loans: BB and B rated loans rose 0.49% and 0.44%, respectively, while CCC & below rated loans declined -1.60%. Industry performance was strong with 52 of the 61 industries posting positive returns. Paper & Forest Products, Pharmaceuticals, and Gas Utilities led, while Metals & Mining, Household Products, and Building Products lagged.

Primary activity subsided in November, declining to \$49.3 billion from \$61.9 billion in October. Net CLO formations remained strong at \$20.3 billion. Two loan issuers defaulted in November affecting \$2.5 billion of loans, following one issuer default in the prior month affecting \$1 billion in par value. The J.P. Morgan 12-month par-weighted leveraged loan default rate ended the month at 1.31%, remaining below the historical average near 3%. Including distressed exchanges, the default rate ended November at 3.16%.

Global investors have shifted focus from tariffs toward macroeconomic conditions, particularly the cooling labor market and rising inflation. Following a data blackout during the federal government shutdown, incoming economic data should garner significant focus. While incoming data has shown a moderating but still resilient domestic economy, each incremental release is shaping policy expectations.

After two consecutive 25 basis points (bps) rate cuts in September and October, the Fed emphasized a data-dependent posture and offered little forward guidance beyond a commitment to flexibility. Markets continue to price a high likelihood of additional easing in December and early 2026, but the Fed has pushed back against assumptions of a pre-set path. Policy risk has also broadened beyond monetary dynamics, with executive actions, fiscal negotiations, and year-end legislative uncertainty exerting increasing influence on rate volatility and risk sentiment.

The U.S. leveraged loan market demonstrated continued relative resilience. Elevated coupons and floating-rate exposure in certain segments helped mitigate the asset class against broader fixed-income volatility as Treasury yields traded within a narrower range than in prior months. Primary markets remained constructive, with steady refinancing and amend-and-extend activity continuing to lengthen maturity runways and reduce near-term refinancing risk. Defaults have risen from cycle lows but remain below long-term averages, and realized losses have been contained given strong market exposure for fundamentally sound issuers. As yield dominates return profiles, we believe issuer selection, capital-structure positioning, and sector-level dispersion remain critical drivers of performance heading into year-end.
